Gator Harley-Davidson WILL NOT provide any tents, tie downs, chairs, tables, extension cords etc so please come prepared.

- Any tent over 144sf shall be flame retardant. All vendors must have in their tent at least (1) 3A40BC fire extinguisher. No smoking allowed in tent area. Any tent over 400sf is required to have (2) 3A40BC fire extinguisher with a current inspection tag.
- Vendors will be responsible for any damage that may occur to any other vendor or property due to their negligence.
- All licenses that are required by the State and City must be readily available upon request
- Florida Department of Revenue requires all vendors selling products to have a certificate number to pay sales tax

- NO FOOD OR ALCOHOL vending allowed without the express pre-approval of the Firefighter Charity
